## SUMMARY/BACKGROUND

On Monday March 7, 2022, Governor Jay Inslee updated Washington's statewide indoor mask policy following updated guidance from the Centers for Disease Control.

With the declining case rates and hospitalizations across the west, California, Oregon, and Washington moved together to update their masking guidance. After 11:59 PM on March 11, California, Oregon, and Washington lifted universal masking requirements for most public locations including schools.

State Indoor Mask Requirements Starting March 12, 2022. Local governments are still able to enact local mask requirements. Many individuals will choose to continue to wear masks. Please be kind and compassionate.

- Healthcare and medical facilities, including hospitals, outpatient, dental facilities, and pharmacies.
- Long term care settings.
- Public Transit, taxis, and rideshare vehicles (federal requirement)
- Correctional facilities
- Private businesses and local governments that want to require masks for their employees, customers, or residents.

# Masks Not Required

- Schools, childcare facilities, and libraries
- Restaurants and bars
- Houses of worship
- Gyms, recreation centers and indoor athletic facilities.
- Grocery stores, businesses, and retail establishments.

# Private businesses can still require masks if they choose. Please respect the rules of the room.

The Skamania County Board of Commissioners passes by approval of this motion action the above listed items to rescind previous COVID related policies and adopt new policy going forward effective March 12, 2022, to follow until such time as the Governor of State of Washington, CDC or WSLNI issues new directives. Upon Board approval, these directives may be reviewed and extended or lessened based on current conditions required by state, federal or local authorities. Beginning March 11,2022 at 11:59 p.m. employees and public are no longer required to wear masks in County Buildings except as listed above under "Still Required". Skamania County will comply with any lingering requirements from Washington State Labor and Industries, CDC and Washington State Governor's Proclamations.

WHEREAS, WHEREAS, the Skamania County Director of Emergency Management reported to the Board of County Commissioners that beginning January 3, 2022, Severe Winter Storm Conditions were having significant impacts throughout Skamania County; and

WHEREAS, the Board of Commissioners of Skamania County declared a local emergency on January 3, 2022 due to significant winter storm conditions which could cause closure of roads, possible evacuation, and damage to roads, bridges, homes, businesses and utilities; and

WHEREAS, the County has now completed its emergency response to that event;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Skamania County that the local emergencies related to the winter storm issues of January 2022 no longer exist, and Resolution 2022-3 is hereby rescinded.

# RESOLUTION NO. 2022-03 RESOLUTION DECLARING A LOCAL EMERGENCY DUE TO WINTER STORM

WHEREAS, the Skamania County Director of Emergency Management has reported to the Board of County Commissioners that beginning January 3, 2022, Severe Winter Storm Conditions are having significant impacts throughout Skamania County; and

WHEREAS, expected accumulations of snow and ice have many roads impassable including State Hwy 14 and 184, which are closed to all traffic; and

WHEREAS, under the above referenced conditions there is substantial likelihood of risk to persons, property and the environment unless further efforts are taken to reduce the threat; and

WHEREAS, the conditions stated above constitute an emergency/disaster for all areas of the County, necessitating activation of the Skamania County Comprehensive Emergency Management Plan and the utilization of emergency powers granted pursuant to RCW 36.40.180, 38.52.070(2), and 38.52.110(1);

NOW THEREFORE, the Board of County Commissioners of Skamania County, Washington, do resolve as follows:

- Section 1. There is hereby declared an emergency, as defined in the Skamania County Comprehensive Emergency Management Plan (CEMP), due to the ongoing threat of Extreme Winter Storm impacts on Skamania County.
- Section 2. Pursuant to the emergency declared in Section 1, County departments and offices, as designated pursuant to the CEMP, are authorized to enter into contract and incur obligations necessary to combat such emergency with approval of the Chair of the Board of County Commissioners to protect the health and safety of persons, property, and the environment, and provide emergency assistance to the victims of such emergency, consistent with the CEMP.
- Section 4. The declaration of a local emergency set forth in Section 1 shall terminate by the issuance of a subsequent rescinding Resolution which shall follow when the Board determines that the extraordinary measures contained herein are no longer required for the protection of the public peace, safety, and welfare.
