

<b><u>ACTION REQUESTED</u></b>	That the Board of Commissioners of Skamania County, by motion action, authorizes staff to advertise for the "Call for Bids" for the purchase of crushed rock.	

**SUMMARY/BACKGROUND**

To purchase crushed rock for resale to other departments for various maintenance activities for 2022.

**FISCAL IMPACT**

The E.R. & R. Fund budgeted \$285,000.00 to cover this contract. The Public Works estimate is \$69,466.50 for this purchase. Other departments can then buy it from the E.R. & R. Fund, as it is required throughout the year.

**DISCUSSION**

This rock purchase is to supply County Road with crushed rock for various maintenance projects.
