The meeting was called to order at 1:31 p.m. on December 13<sup>th</sup>, 2022, at the Skamania County Courthouse, 1<sup>st</sup> Floor Meeting Room, 240 NW Vancouver Avenue in Stevenson, with Board of Health Elected Representatives Commissioners Robert Hamlin and Richard Mahar, Chair present and appointed Board of Health members Scott Yerrick and Katie Walker present. Board of Health member Ann Leuders was present via Zoom. Commissioner T.W. Lannen was absent.
