# GUARDIANSHIP and SUPPORTED DECISION MAKING

Fairly recent changes in Washington State law re-structured "Guardianship" to include a range of opportunities including "Supported Decision Making." Understanding the options allows you to make an informed decision for, and with, your loved one, at any age.

Her specialty is looking into guardianships to determine the best route for each circumstance, full guardianship and conservatorship to Power of Attorney and Supported Decision Making options. Ms. Linden advises that what is most important is
