She reported she will advertise for a Public Health Nurse in two weeks. She also mentioned advertising efforts for WIC and clinicians working from home.

Dr. Steven Krager, Deputy Health Officer gave an update on Covid-19 including definition of close contact. He reported on a testing plan to prioritize groups and high-risk individuals. He commented on social distancing, Covid-19 symptoms, virus exposure, and accuracy of testing.

Arnold Bell, Engineering Tech reported on Environmental Health. He reported the absence of bats and rats and that no new septic permits will be granted due to Covid-19, only emergency permits will be addressed.

Covid-19discussion continued regarding immune compromised individuals, vitamin evidence, and data reporting. Testing, tracking and treatment were also mentioned.

MINUTES OF SKAMANIA COUNTY BOARD OF HEALTH MEETING

May 5, 2020 Skamania County Courthouse 240 NW Vancouver Avenue, Room 18 Stevenson, WA

A Special Meeting of the Skamania County Board of Health was called to order at 1:30 p.m. on May 5, 2020 at the Skamania County Courthouse, 1st Floor Meeting Room, 240 NW Vancouver Avenue in Stevenson, with Board of Health Commissioners, Richard Mahar, Tom Lannen, and Robert Hamlin, Chair present. The Special Meeting was held to discuss current COVID-19 issues, including Governor Inslee's decision to ease outdoor restrictions.

The Board discussed Governor Inslee's decision to ease outdoor restrictions. A variance application to the Governor to move to Phase 2 of the Governor's plan was discussed. The Board of Health, and the Board of Commissioners will need to approve and endorse the application as well as documentation from Skyline Hospital certifying bed capacity for COVID 19 patients and PPE supplies and the local Public Health Officer's recommendation. The application will include testing information, including availability and accessibility, and how many tests have been performed in the county by week over the past three weeks. Other items to be submitted with the application are the local health jurisdiction's plans and resources to perform case investigations and contact tracing, housing plans and resources to house people in isolation or quarantine who do not have a home or wish to isolate or quarantine outside the home. Also plans and resources to provide case management services, plans and resources to rapidly respond to outbreaks in the community and congregate settings will be included.

Commissioner Lannen moved, seconded by Commissioner Mahar to direct Deputy Health Director Steven Krager to complete the application for the County's COVID 19 variance so that the County can move to a Phase 2 standing per Governor Inslee's phased approach to reopening the state. The motion carried unanimously.
