## **ORDINANCE No. 2018-06**

## AN ORDINANCE AMENDING THE SWIFT SUBAREA ZONING MAP

**WHEREAS,** RCW 36.70 authorizes Skamania County (the County) to adopt or amend zoning regulations and a zoning map; and

**WHEREAS,** RCW 36.70 authorizes Skamania County (the County) to adopt or amend Comprehensive Plans and Subarea Plans; and

**WHEREAS,** the Board of County Commissioners initiated amendments to the Swift Subarea Plan and Zoning Map on March 15, 2016; and

**WHEREAS,** a SEPA Mitigated Determination of Non-Significance (DNS) was issued on February 14, 2018, after environmental review of the proposed amendments was completed; and

**WHEREAS**, the Planning Commission, after holding a public hearing on May 15, 2018, recommended amendments to the Swift Subarea Plan Map and Swift Subarea Zoning Map; and

WHEREAS, the map amendments protect the general health, safety, and welfare of the public; and

**WHEREAS,** the Board of County Commissioners, having provided proper notice in the Skamania County Pioneer, held a public hearing on July 10, 2018, and approved Resolution 2018-38 on July 10, 2018, amending the Swift Subarea Plan Map; and

**WHEREAS,** the Swift Subarea Zoning Map amendments are consistent with the Swift Subarea Plan; and

**WHEREAS,** the Board of County Commissioners, having provided proper notice in the Skamania County Pioneer, held a public hearing on July 10, 2018, on Ordinance 2018-06; and

**WHEREAS,** the Board of County Commissioners approved Ordinance 2018-06 on July 10, 2018; and

**NOW THEREFORE BE IT HEREBY ORDAINED AND ESTABLISHED** the Board of County Commissioners adopts Ordinance 2018-06, amending the Subarea Plan Zoning Map as follows:


**SECTION 1:** Approximately 152 acres in Section 21 of Township 7 North, Range 5 East, Willamette Meridian located at the west end of the Swift Reservoir and east of Glacier View Drive are hereby rezoned from Mountain Recreational 20 (MR20) to Mountain Recreational 5 (MR5) as depicted in Exhibit 1.

**SECTION 2:** Approximately 380 acres in Section 23 and Section 24 of Township 7 North, Range 6 East, Willamette Meridian located at the east end of the Swift Reservoir near Pine Creek and USFS 25 are hereby rezoned from Mountain Recreational 10 (MR10) to Mountain Recreational 5 (MR5) as depicted in Exhibit 2.


