The Commissioners' business meeting was called to order at 9:30 a.m. on Tuesday, March 16, 2021 at the Commissioners' Meeting Room, 240 NW Vancouver Avenue in Stevenson, with Commissioners Richard Mahar, Robert Hamlin, and T.W. Lannen, Chair present.

The Pledge of the Allegiance was led by Debbie Slack, Clerk of the Board.

There was no public comment.

Commissioner Mahar moved, seconded by Commissioner Hamlin and the motion carried unanimously to approve the Consent Agenda as follows:

She reported on the Underwood Conservation District Winder Workshop, the 10th Annual Invasive Species Awareness Week Workshop, Rocky Mountain Elk Foundation grant proposal, website updating, and dormant stem treatments. She also reported on grant funding for the knotweed program, seasonal staff hiring, vehicles and an alert concerning the invasive weed, Zebra Mussel.

The Board reported on various meetings they attended. Commissioner Mahar reported on Gorgeous Nights on YouTube, a Fair Board meeting, a National Association of Counties call, and a weekly call with Governor Inslee. Commissioner Hamlin reported Bi-State Recreational meeting, and Legislative Steering Committee. Commissioner Lannen reported on speaking with Emily Platt of the Forest Service Regional Office, a National Forest Counties and Schools Coalition call, and Skamania County Economic Development Council. He also updated the Board on Encumbered Lands, HB 4205 funding, and Rescue COVID funds. There will also be a call with the Timber Counties on March 17th.

Kirby Richards, Community Health Administrative Director reported on a call with the Health Secretary and CDC regarding COVID Vaccines, Department for Health funding from FEMA, and school district meetings with Dr, Krager.
