## **RESOLUTION 2021-21**

(Amending Resolution 1977-22, Establishing a Cumulative Reserve Fund to be known as County Building and Grounds Cumulative Reserve Fund to change funding purposes)

WHEREAS, RCW 36.33.020 allows the Board of Commissioners to establish cumulative reserve funds by resolution; and

WHEREAS the Skamania County Board of Commissioners believes it is in the best interest of Skamania County to have funds available for the purpose of acquiring lands; or constructing, maintaining, remodeling, or operating any improvements or facilities located upon all county property; and

WHEREAS the Skamania County Board of Commissioners approved Resolution 1977-22, Establishing a Cumulative Reserve Fund to be known as County Building and Grounds Cumulative Reserve Fund on November 9, 1977, for the purpose of acquiring land, constructing improvement thereon, or maintaining or operating said improvements; and

WHEREAS the Board of Commissioners wish to amend Resolution 1977-22, County Buildings and Ground Cumulative Reserve Fund for the following purposes, acquiring lands, constructing improvement thereon, and maintaining and operating all county owned facilities and properties for the efficient operation of the government of Skamania County, Washington"; and

**NOW THEREFORE BE IT RESOLVED** that the County Treasurer is directed to pay from said fund, such amounts of money as the Board of County Commissioners directs for the following purposes, acquiring lands, constructing improvement thereon, and maintaining and operating all county owned facilities and properties for the efficient operating of the government of Skamania County, Washington.
