The meeting was called to order at 1:30 p.m. on March 8, 2022, at the Skamania County Courthouse, 1<sup>st</sup> Floor Meeting Room, 240 NW Vancouver Avenue in Stevenson, with Board of Health Commissioners, Robert Hamlin, T.W. Lannen, and Richard Mahar, Chair present.

There was no public comment.

Commissioner Lannen moved, seconded by Commissioner Hamlin and the motion carried unanimously to approve the Consent Agenda as follows:

1. Minutes for meeting February 8, 2022

Tamara Cissell, Community Health Director discussed the process for the new expanded Board of Health. She also discussed office space for her department, the most recent COVID 19 mask mandate COVID 19 statistics. She will continue to provide the Board a weekly report on Thursdays to keep them updated on COVID 19 case numbers. She also reported there are tests and masks available. She shared with the Board information about the Healthy Communities program. Jean Campbell is the coordinator for that group.
