Minutes for Meeting April 5, 2022

The Commissioners' business meeting was called to order at 9:30 a.m. on April 5, 2022, at the Commissioners' Meeting Room, 240 NW Vancouver Avenue in Stevenson, with Commissioners Robert Hamlin, T.W. Lannen, and Richard Mahar Chair present.

The Pledge of the Allegiance was led by Debbie Slack, Clerk of the Board.

Debbie Allinger, County property owner commented on zoning in Carson.

Commissioner Lannen moved, seconded by Commissioner Hamlin and motion carried unanimously to approve the Consent Agenda as follows:

1. Letter of support for Columbia Cascade Housing Corporation's Assisted Living Facility
2. Resolution 2022-23 Award of Contract for the Official County Newspaper for one year beginning July 1, 2022, through June 30, 2023

Commissioner Hamlin moved, seconded by Commissioner Lannen and the motion carried unanimously to approved payroll dated April 5, 2022 in the total amount of \$621,591.04 with \$377,789.57 being Current Expense, covering payroll warrant numbers 43603 through 43630 and direct deposit numbers 72962 through 73134.

Commissioner Hamlin moved, seconded by Commission Lannen and motion carried unanimously to approve ratification of a letter of support to Skamania County Port for the Cascade Business Park Project.

Commissioner Lannen moved, seconded by Commissioner Hamlin and motion carried unanimously to approve ratification of letters of support to Representative Jaime Herrera Beutler, Senator Patty Murray, and Senator Maria Cantwell for FY23 Community Project Funding request for the Wind River Road Stabilization Project.
