Minutes for Meeting of July 6, 2022

The Commissioners' business meeting was called to order at 9:30 a.m. on Wednesday, July 6, 2022, at the Commissioners' Meeting Room, 240 NW Vancouver Avenue in Stevenson, WA with Commissioners Robert Hamlin, T.W. Lannen and Richard Mahar, Chair present.

The Pledge of the Allegiance was led by Debbie Slack, Clerk of the Board/Financial Management Coordinator.

There was no public comment.

Commissioner Lannen moved, seconded by Commissioner Hamlin and the motion carried unanimously to approve vouchers for the period dated July 6, 2022, in the total amount of \$66,605.69 with \$22,359.14 being Current Expense, covering warrant numbers 187588 through 187634.

Commissioner Hamlin moved, seconded by Commissioner Lannen and the motion carried unanimously to approve payroll for the period dated June 16, 2022, through June 30, 2022, in the amount of \$643,396.27 with \$386,329.73 being Current Expense, covering payroll warrant numbers 43721 through 43741 and direct deposit number 74029 through 74214.

The Board reported on meetings they attended.

The meeting recessed at 9:51 a.m. and reconvened at 10:00 a.m. with Commissioners Robert Hamlin, T.W. Lannen and Richard Mahar Chair, present.

Commissioner Hamlin moved, seconded by Commissioner Lannen and motion carried unanimously to approve the Final Short Platt for Muddy River Subdivision.

The meeting recessed at 10:05 a.m. and reconvened the same day at 11:00 a.m. with Commissioners Robert Hamlin, T.W. Lannen and Richard Mahar Chair, present.

The Board held a workshop to discuss Elected Officials salaries.

Commissioner Lannen moved to change the percentage on Resolution 2008-62 to 40%. The motion died for lack of a second.

Commissioner Hamlin moved to change the percentage on Resolution 2008-62 to 41%. The motion died for lack of a second.

Commissioner Lannen moved, seconded by Commissioner Hamlin and the motion passed unanimously to change the percentage on Resolution 2008-62 to 40.5%.

The meeting adjourned at 11:20 a.m.
